Forgotten women project: Research team



Đermana Šeta, European research team coordinator, is a researcher at the Institute for Islamic tradition of Bosniaks. She is currently working on establishing a Department for Women and Family in the Islamic community of Bosnia and Herzegovina. She holds a MA degree in Religious Studies from the Centre for Interdisciplinary Postgraduate Studies, University of Sarajevo (in cooperation with Arizona State University, University of Oslo and University of Copenhagen). She serves as the Head of Freedom of Religion Commission of the Islamic Community in B&H, a fellow at the Center for Advanced Studies (Sarajevo) and CER Nahla assembly president (Sarajevo). Previously she worked as the Head of

Research Department at the Center for Research and Education “Nahla”. She (co)authored books/volumes/articles on religion, human rights and women. She is in the process of preparing her PhD thesis on Muslim women in post-2nd World War Bosnia and Herzegovina.



Dr Asmaa Soliman, national researcher for Germany, is a Research Associate at the ESRC-funded project Muslims, Trust and Cultural Dialogue in London. In addition, she is a Teaching Fellow at UCL. Dr Soliman has finalised her PhD at UCL’s Centre for Multidisciplinary and Intercultural Inquiry, majoring in Sociology, Political Sciences and Cultural Studies. Her research deals with European Muslim youth culture, questions of identity and public expressions. Prior to this she studied Arts and Culture, Media Culture and International Politics. Asmaa’s main research interests include the sociology of religion, artistic expressions, identity, Islam in Europe and Europe-Middle East relations.



Mariska Jung, national researcher for the Netherlands, works as a researcher, practitioner and volunteer in the fields of migration, asylum and anti-racism, with a special focus on gender and sexuality. She graduated three times with cum laude and holds a MSc degree in Migration Mobility and Development Studies from SOAS University of London, a BSc in Interdisciplinary Social Sciences and a BA in Philosophy from the University of Amsterdam.

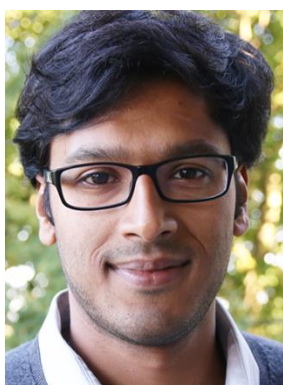
